Frank Barker shared with the group a hard copy of a letter he had prepared in regards to the Community Benefit Scheme:

- The letter outlined two components that he thought the scheme should consider: including a palliative care facility and electricity tariff reduction.
- A general discussion was held on the community benefit scheme and what everyone thought would be suitable beneficiaries. Frank Boland indicted that Infigen Energy was not a retailer of energy and there practicality issues of offering a discounted tariff.

Mayor Anne Jones suggested that we maintain a register of these suggestions and that this be added to and refined in future meetings. All ideas should be on the table at this stage. Moved by Lyn Jarvis and seconded by Simon Barton.
